# NHS planning guidance 2016/17 – 2020/21



### **NHS Planning Guidance**

The NHS in England has published new guidance saying that local organisations involved in planning and providing health and care services in England must prepare a five year plan which sets out how they will improve quality of services, address funding challenges, and improve the health and wellbeing of people living in their area.

The guidance says that local organisations should engage patients, service users, carers and the public in developing these plans. They should also engage voluntary and community groups. The plans they develop should include ways that voluntary and community groups – and people who use services – can be involved in the delivery of services and support locally.

#### **Get involved**

Your local area will have to have developed its final plan by June 2016. So if you would like to be involved, now is the time to do so.

Lots of different local organisations will be involved in deciding what geographical area the plan will cover, and in developing the plan itself. If you write to the Chief Officer who leads your local Clinical Commissioning Group (CCG) they will be able to tell you more about how the process is working in your area.

To help you do this, National Voices has prepared a template letter that you can customize and send to your CCG.

#### **Contact your CCG**

You can search for contact details for your local CCGs on the NHS Choices website: http://www.nhs.uk/Service-Search/Clinical%20Commissioning%20Group/LocationSearch/1

Enter your postcode and then click on the name of the closest CCG to your area to find contact details for the organisation. If you can't find a named contact, you can just address your letter to 'the Chief Officer' and send it to the general CCG email or postal address.
